WHEREAS, James Maley, Esquire through his representation of the Borough of Lindenwold obtained confidential information including but not limited to redevelopment strategy, redevelopment plans, demographic information, and confidential attorney/client information concerning the Borough of Lindenwold's legal position on redevelopment of the Arborwood Condominium Association; and

WHEREAS, the Borough of Lindenwold continued it's plan for redevelopment of the Arborwood Condominium Association, subsequent to termination of the attorney/client relationship with James Maley, and continued the redevelopment project with other redevelopment counsel; and

WHEREAS, James Maley, Esquire is now representing Pine Ridge Investments, LLC and Wakefield Holding, LLC in an action against the Borough, arising out of the same matter in which James Maley, Esquire previously represented the Borough of Lindenwold; and

WHEREAS, there exists a clear conflict of interest in James Maley, Esquire representing Pine Ridge Investments, LLC and Wakefield Holdings, LLC in a matter which is materially adverse to the Borough of Lindenwold, and which constitutes the same project for which James Maley, Esquire previously represented the Borough of Lindenwold;

NOW THEREFORE BE IT RESOLVED, by the Mayor and Borough Council of the Borough of Lindenwold, that the Solicitor of the Borough of Lindenwold is authorized to forward correspondence to James Maley, Esquire, and request that James Maley, Esquire recuse himself as counsel of record, and discontinue representation of Pine Ridge Investments, LLC and Wakefield Holdings, LLC, as a result of the clear conflict of interest James Maley, Esquire maintains in representing Plaintiffs in the matter of Pine Ridge Investments, et. al v. Lindenwold, et. al, filed in Camden County Superior Court under docket number L-2562-17.

Barbara Clark Borough resident, was concerned about the abandon cars with flat tires on Elm Ave. She has reported this to Mr. Hans. Mr. Hans has looked into this issue but let the resident know there is a process. One of the cars is on the street which Mayor Roach will address with the Police Department. She also has concerns in regard to vacant properties on Elm Ave. and the high grass. She also was describing the area between Irving, Linden and Maple Ave. with 2 red mustangs that are damaged and sharing the same tag. There is a landscaper behind her that has no mercantile license and needs a variance to operate the landscaping business in the residential area. He also has two dogs that bark all night long. The Business name is Rays Landscaping. Code Enforcement will be looking into.

Nadine Washington, Neighbors who care, was inquiring as to if they are able to utilize the Senior Citizens building for the Seniors to have a Zumba Class. She does not want to rent the building; they just want to use the building for the seniors. Mayor Roach advised that we generally do not allow organizations to utilize the building as we have had bad experiences in the past. Their organization is a non-profit. The Zumba instructor would charge a minimal fee for her service only. President Randolph Sharpe suggested that she write up something for council to discuss. Councilman Burrows and Mayor Roach thanked Mrs. Washington for all that she does for the Community.
