RESOLUTION 2019:126 Shared Service with Lindenwold Board of Education

WHEREAS, the Borough of Lindenwold, 15 North White Horse Pike, Lindenwold, New Jersey, and the Lindenwold Board of Education, 801 Egg Harbor Road, Lindenwold, New Jersey, recognize that it is imperative to search for efficient means to reduce spending through creative and innovative ideas and programs which benefit their community, and

WHEREAS, the "Uniform Shared Services and Consolidation Act", N.J.S.A 40A:65-1 et seq. (the "Act"), authorizes local units of the State of New Jersey to enter into an agreement with any other local unit or units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction, and

WHEREAS, the circumstances now exist where it is appropriate for the respective parties hereto to join together for the purpose of an Interlocal Agreement authorizing Law Enforcement Officers be assigned to the Lindenwold School District and for the upkeep of the Lindenwold Park.

Matters for Discussion:

Councilwoman Sinon reminded everyone to come out to the annual Hooked on Fishing on June 8 from 9:00am to noon. Councilwoman Hess announced the Memorial Day Tribute at 9:00am at the Lindenwold Park. The first movie is on June 7<sup>th</sup> with Ralph Breaks the Internet.

Mayor Roach opened the meeting to the public.

Representative of one of the owners of Arborwood came in to question the paperwork by the Borough regarding the properties. He has been unable to reach the Redevelopment Attorney. The Borough Solicitor requested his information in order to have the Redevelopment Attorney contact him.

Ruth Morgan, resident, questioned the action taken for the parking problems due to the school. Chief Brennan informed the resident that police were assigned to the area as well as a letter was sent home with the students addressing the parking issue. No obstructions were noted. Resident continued to discuss the situation with the Police Chief. Police Chief advised resident to contact the police if her mailbox is blocked.

Diane Veteri, resident, questioned why nothing is done unless she calls and complains about the vacant property. Councilman DiDomenico is familiar with the property and owner was out cutting the grass. Resident stated that the back yard and weeds bordering her property were not addressed. Discussion continued about violations including ones that she has received regarding trash that she tried to resolve with the Public Works Department. Public Works Supervisor tried to explain the procedure.

Robin Sadler, resident, informed Council of the excessive amount of noise at the park on Myrtle and Emerson after dusk. Mayor explained that this is due to the Lindenwold Park being closed. Public Works Supervisor stated that work has started and may be approximately three weeks to complete. Mayor asked the Police Chief to look into this matter. There being no one else desiring the floor, the Mayor closed the meeting to the public.

Mayor Roach wished everyone a Happy Memorial Day and invited them to attend the Memorial Tribute. President Randolph-Sharpe added that the newsletters should be mailed on June 1.
