Mayor Roach called the meeting to order.

Borough Solicitor conducted a hearing for an abandoned and unsafe property located at 913 Elm. He provided the history of the property including the difficulty in serving the owners of violation. Property has been foreclosed and is now owned by Ditect Financial. The original owner was in the process of obtaining quotes for remediation or demolition. The Borough Solicitor swore in the Construction Official regarding his inspections of this property. The Construction Official reported his findings from his inspections and the list of violations and safety issues. He recommends demolition. Councilman Strippoli questioned the location of the property which is behind Linden Town. Council voted to accept recommendation for demolition and a lien to be placed on the property. The Construction Official updated Council regarding other properties in Lindenwold. The property formerly known as Fairway Pharmacy has applied for permits and is moving forward. The Repair Shop on Laurel Road has removed the proposed second floor. Property on West Park was demo by the bank and the environmental study has been completed on two properties, one on the White Horse Pike and one on Linden, with specifications to be prepared for bids for demolition. He estimates that the former cleaners on the White Horse Pike will cost approximately \$100,000. Mayor asked if a lien will then be placed on the property which the Official confirmed. The Construction Official is hoping to complete three demolition projects for unsafe structures this year.

RESOLUTION 2018:98 Demolition of 913 Elm

WHEREAS, the Borough of Lindenwold having notified the owner of the real property located at Lot 4 Block 50, Located At 913 Elm Ave., Lindenwold, NJ 08021 of a potential violation of Borough Code Chapter 160, Article VII,, which prohibits dangerous, damaged, and unfit structures, and

WHEREAS, notice was provided to the owner of the property, and all lien holders, mortgage holders, and interested parties maintaining an encumbrance and/or lien on the property, consistent with the requisites of Chapter 160, Article VII, and

WHEREAS, on February 28, 2018, the Mayor and Council heard testimony from the Construction Official concerning the real property located at Lot 4 Block 50, Located At 913 Elm Ave., Lindenwold, NJ 08021 concerning the conditions and circumstances of the real property, and no interested party having appeared or otherwise filing opposition to the Notice and Complaint, and

WHEREAS, the Mayor and Council of the Borough of Lindenwold after hearing the testimony of the Construction Official, having made a factual determination that Lot 4 Block 50, 913 Elm Ave., Lindenwold, NJ 08021, is in violation of Borough Code Chapter 160, Article VII,, and maintains conditions on the property to include without limitation the following:

Defects increasing the hazard of accident, fire, or other calamities.

Dilapidation.

Disrepair or structural defects.

Lack of adequate light, sanitary facilities or ventilation.

Uncleanliness.

Failure to comply with the property maintenance code.

Failure to comply with applicable Health Ordinances Rules and Regulations.

Is otherwise in violation of N.J.S.A. 40:48-1 et seq., and the provisions of Borough Ordinance 160; and NOW THEREFORE, be it resolved by the Mayor and Council of the Borough of Lindenwold, County of Camden, State of New Jersey on this 28th day of February, 2018 that Lot 4 Block 50, located at 913 Elm Ave., Lindenwold, NJ 08021 is in violation of Borough Code Chapter 160, Article VII,. The Borough further finds that it is

unreasonable and untenable to remediate the property, given the dilapidated and damaged status of the property. The Borough finds that it is in the best interest of the Community to demolish the property, for the safety and general welfare for the residents of the Borough of Lindenwold, and the public in general. The Construction Official is authorized to obtain bids to demolish the property, and a lien for all costs associated with demolition and this application shall be placed upon the property to indemnify the Borough for all costs associated with the violation of Borough Code Chapter 160, Article VII,.

Mayor Roach personally and on behalf of Council thanked the retiring Judge Trabosh for his years of service. He welcomed the new judge, Nicholas Trabosh. The Mayor also announced the award for funding for Chews Landing Road Sidewalks.

Mayor Roach opened the meeting to the public.

Hank Urban, resident, stated that Lindenwold has housing issues not just at the apartments. He presented pictures to Council. Mayor explained that the Borough has actively handling unsafe properties with its current program. The resident continued to state problems on State Avenue including vacant properties, Comcast cutting wires and leaving these wires laying on the ground and the house that is a junk yard. Mayor and resident continued to discuss areas of concern. The resident is also upset about a loose dog that has not been handled despite numerous calls to police. Mayor recommended contacting Animal Control. Resident stated that no one seems to care. Code Enforcement Supervisor will look into these matters.

Joe Amodeo, resident, questioned the fire budget that passed excluding the hiring of full time employees. He expressed how impressed he was that they were able to purchase a new truck without raising taxes. The Mayor commented how economically they try to operate and that they were also able to join with a grant to get new air packs. The resident thanked everyone for going above and beyond to help residents.

Melvin Atkinson, new business owner, explained his new security business that he opened in Lindenwold. President Randolph-Sharpe asked how he found his employees. Owner stated through job fairs. Council welcomed him to Lindenwold.

Former Judge Trabosh, thanked Mayor and Council. He spoke of the dedication of the Court Administrator and the support he has received over the years that has been incredible. He commented on the respect shown by all the employees of the Borough and that Lindenwold has the best Court Administrator. President Randolph-Sharpe asked what he will be doing which he responded that he will continue with his law practice. He also stated that the new judge has been substituting and will do well.

Christopher Barker, resident, has questioned about the cars that continue to fly up and down Gibbsboro Road. The Mayor responded that the Police Department recently monitored the area and that the traffic study has been completed. The Police Chief added that the department is currently working near Park Avenue due to construction. President Randolph-Sharpe commented on the added lights that have helped. The Police Chief explained how they were able to operate in order to keep traffic flowing. The Police Chief informed Council of the next phase that will be starting soon.

There being no one desiring the floor, the Mayor closed the meeting to the public.

Motion was made by President Randolph-Sharpe, second by Councilman Strippoli that the meeting be adjourned. Voice vote was unanimous in the affirmative. Motion carried.
